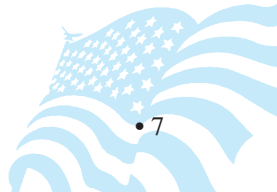

Our State Government

Montana is governed by a state Constitution approved in 1972, which replaced its original 1889 Constitution. The new Constitution and a body of state laws are administered by Montana's executive officers and by various boards and commissions. The governor is elected to a four-year term and is prohibited from seeking re-election after holding the office for eight years in any 16-year period. The governor holds a relatively strong veto power over proposed legislation.

The lieutenant governor, attorney general, auditor, secretary of state and superintendent of public instruction are also elected for four-year terms and subject to the same term limits as the governor. A copy of the Montana Constitution can be purchased for a small fee from: Secretary of State, State Capitol, Helena, MT 59620.

The Montana Legislature consists of a 50-member Senate and a 100-member House. Senators hold four-year terms, and House members serve two-year terms and all are subject to the same term limits as above. Regular legislative sessions convene in January of odd-numbered years, for a maximum of 90 working days. Special sessions of the Legislature may be called by either the governor or the Legislature itself.

The highest court of appeals in Montana is the state Supreme Court, which consists of one chief justice and six associate justices — each elected to eight-year terms. The trial courts for major civil and criminal cases are the state's 56 district courts. These jurisdictions are presided over from one to four judges, each elected to a six-year term. Municipal courts, police courts, and justice-of-the-peace courts handle less serious cases.

Montana includes governments for 56 counties and for 125 incorporated cities and towns. Local government most frequently employs a three-member board of commissioners on a county level and a mayor-council form on a municipal level — although seven local governments operate under the commissioner-manager system, including five of the state's largest cities.

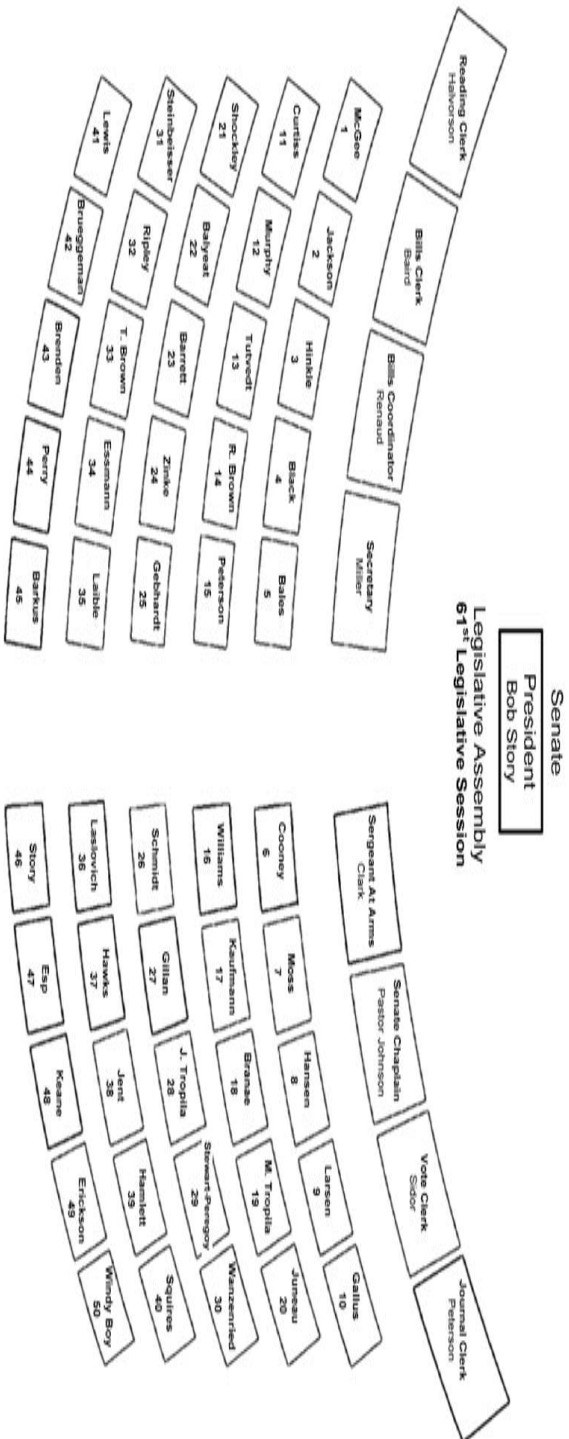

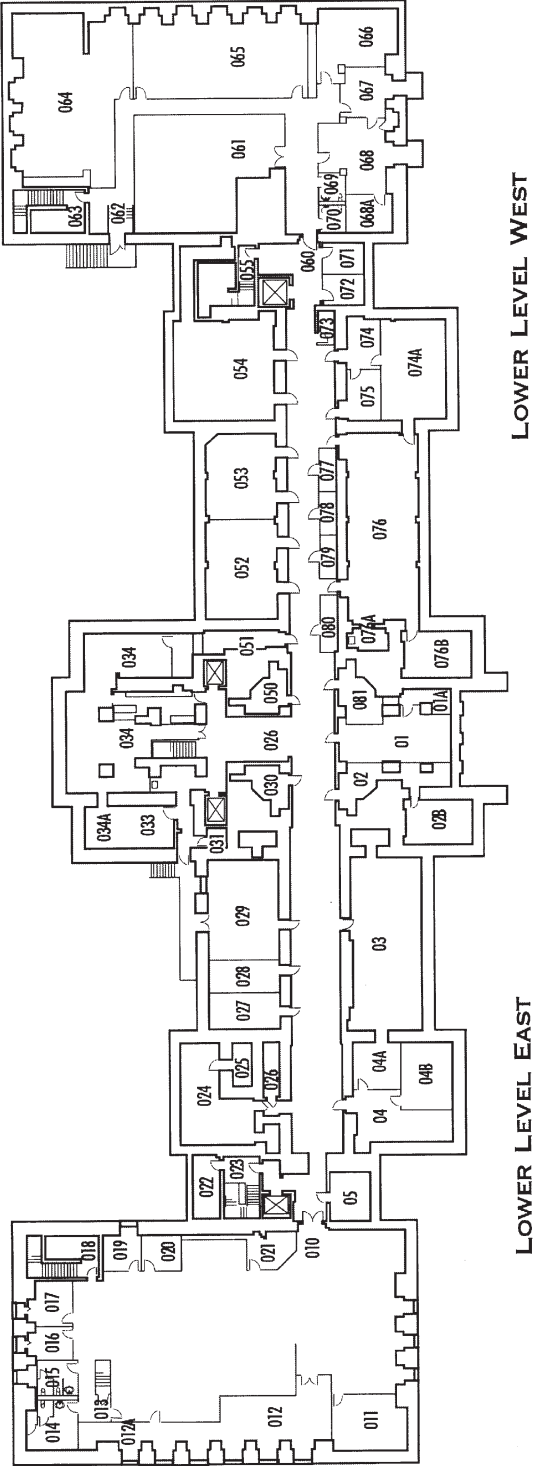

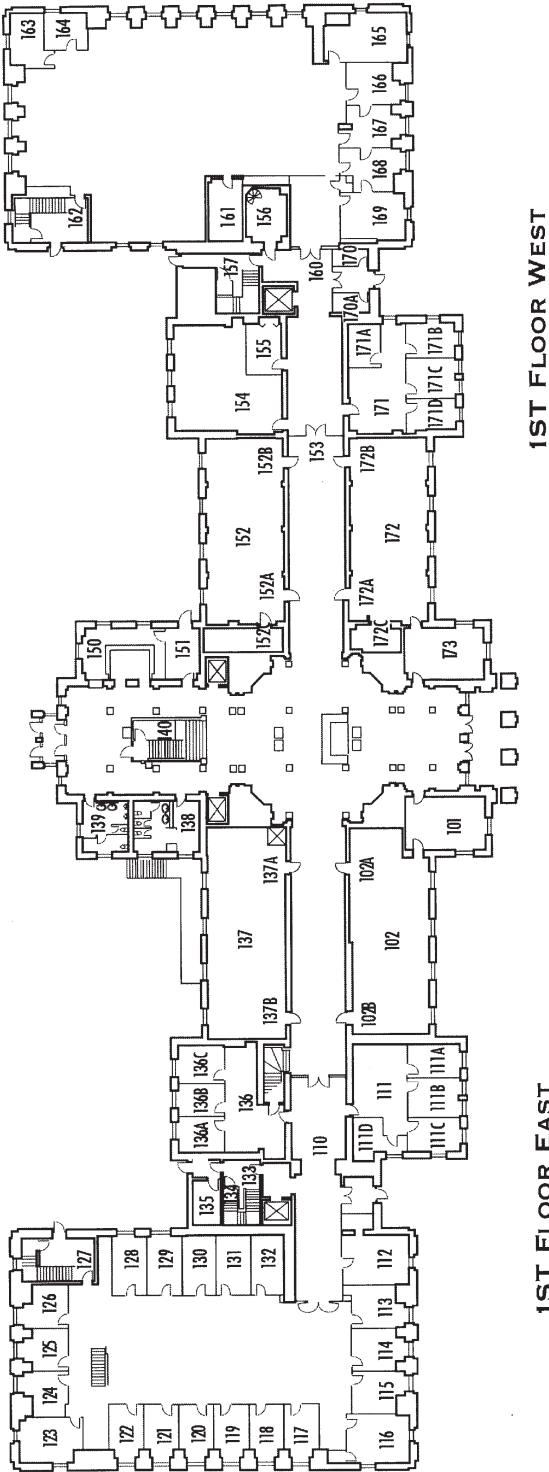
Capitol Floor Plan

LOWER LEVEL FLOOR



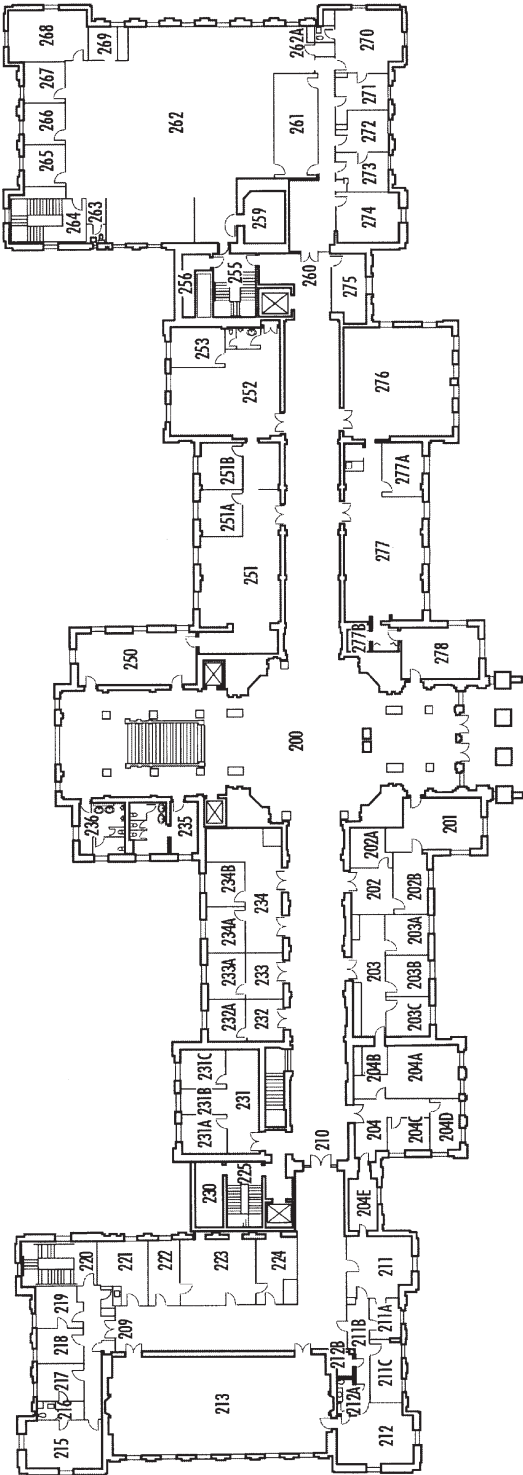
Capitol Floor Plan

FIRST FLOOR



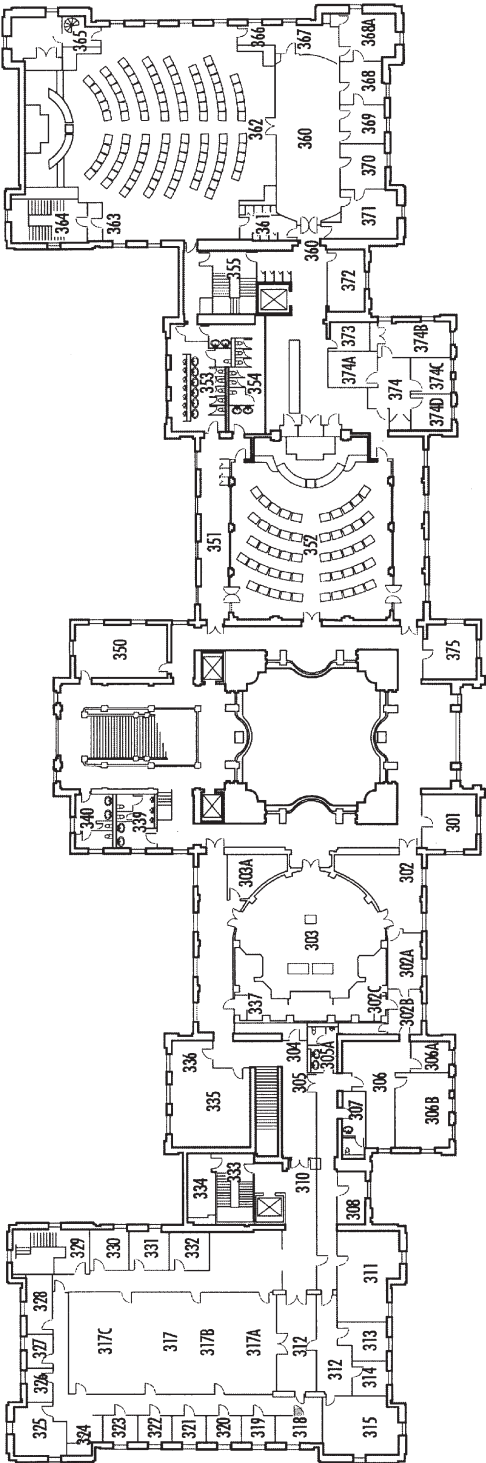
Capitol Floor Plan

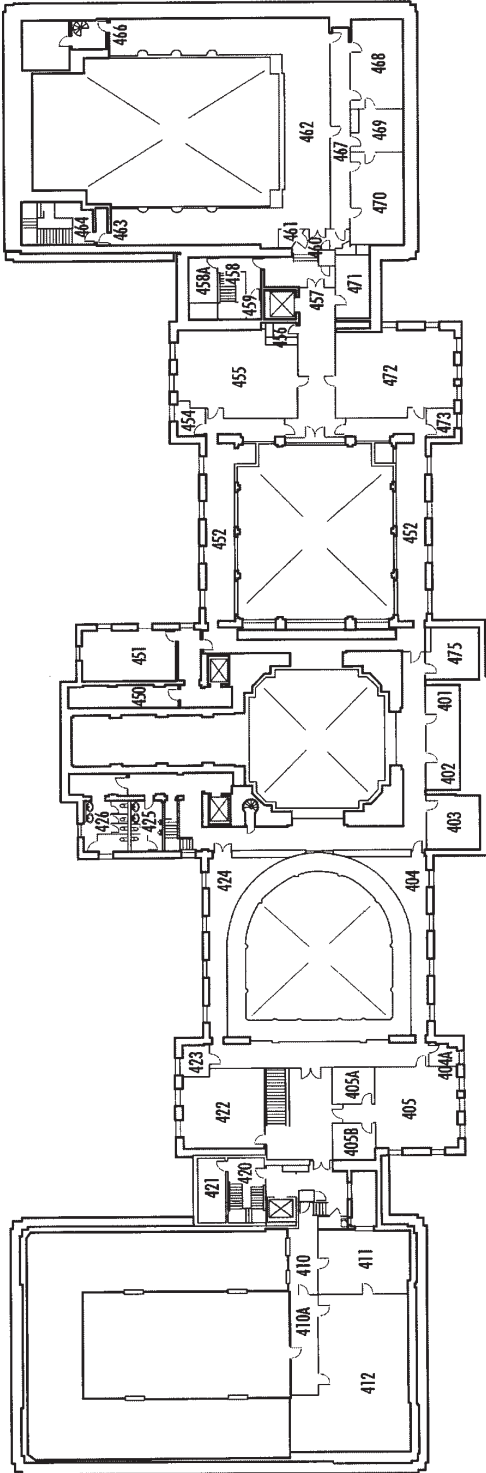


3RD FLOOR WEST
